1. **1 National Visa Application Original and a photocopy Print do not use Cursive.** The Consulate will render applications with whiteout, crossed out or written over answers invalid.
2. **1 professionally-taken, color photo with a white background (passport type) glued to the application.**
3. **Original Passport** (plus photocopy of the main page) valid for a minimum of 3 months after returning from Spain. The passport must have a 2 blank page on which the visa can be affixed.
4. **Drivers License, State ID or University ID** (whichever provides proof of residency in the Consulate's jurisdiction). Plus photocopy
5. **Proof of Finance Means to live in Spain** (Originals and photocopies) in **Spanish**

At least one of the following documents must be submitted:

Your latest 3 months' bank statements which show a minimum balance of \$2800.00 on each statement (calculated at \$700 per each month of stay in Spain) Online printouts are not acceptable but Consulate will accept bank printout if it is stamped and signed with banker's business card attached.

Bank statements do not need to be translated into Spanish.

If a parent is providing this financial information, they must ALSO submit the Proof of Financial Means Form (located on our website). Their signature on this form must be notarized. Attach the following to this form: notarized copy of parents ID, original and notarized copy of student's birth certificate, parent's 3 most recent bank statements (see above) **Bank statements do not need to be translated into Spanish.**

Financial Aid students may instead attach an original official letter from the institution that has granted the aid, indicating the amount allocated in their name. Online printouts or photo copies will not be accepted

6. SAI will send you the following letters to complete your application: **Official Acceptance Letter, Proof of Insurance Letter, and SAI Enrollment Letter, all in Spanish.** Originals and photocopies
7. **Evidence of your migratory status in the USA** (Only for non-US citizens) Provide your Alien Registration Card or valid U.S. long term Visa (original and photocopy). Applicants holding a Student Visas must also present their I-20 (original and copy) signed by the university on the last page and a copy of their F-1 Visa.
8. **Visa fee** Exact cash or a Money Order payable to the Consulate General of Spain Los Angeles will need to be included with your application. US Citizens will pay \$160.00. For all others please check the Consulate's website.
9. **Disclaimer Form** (located on our website)

All visas must be picked up in person by the applicant

It is advisable that you make a copy of your visa application materials for your personal files
